Policy Guidelines

The Johnsville Public Utility District (JPUD) is committed to providing safe drinking water and water for fire protection to its customers. The JPUD feels certain restrictions need to be followed in order to provide this service. A "Will Serve Letter" will be considered and issued by the District upon completion of an application and will describe the location, type of service, and the specific conditions under which the District will provide service.

Service Connection Guidelines

New users assume all responsibility when connecting to the JPUD main service line and will obtain professional advice and direction recognizing there are existing surveys for future streets, easements, and property lines on file with Plumas County.

All State and local requirements and guidelines will be followed.

The JPUD shall notify the applicant in writing of any cross-connections or other potential contamination hazards that have been identified during the initial inspections. The customer shall immediately remove or isolate any potential cross-connections or any other potential contamination hazards on their property.

Access to our existing water lines may require some applicants to cross the private property of other customers. Additionally, they may have to access and cross public land, private easements, and roads. The JPUD assumes no responsibility or liability for these transactions nor are we able to assist with legal or professional advice.

All costs incurred to access JPUD service is the sole responsibility of the applicant who must comply with all county, state, and federal government regulations before the JPUD will provide access to service.

No party will connect to our service without prior written notice from the JPUD.

Fee Schedule

	(a) Refundable deposit including any additional costs to the district. Balance will be refunded upon completion of the project. Any costs exceeding initial deposit will be billed to customer.
